Annie Heisey is an artist and educator living and working in her native city of Pittsburgh, PA. Heisey's work has been exhibited across the country in galleries and institutions including the Boston Center for the Arts, Site: Brooklyn Gallery in Brooklyn, NY, and the Carnegie Museum of Art in Pittsburgh, PA, and is included in the collections of Clatsop Community College in Astoria, OR, and Arthur S. Goldberg.

"The process of painting for me is a metaphor for the constantly shifting way I see the world. I have always been fascinated by the way strokes of paint can come together to build and describe a form, and also how they can dissolve that form and return to simply being strokes of paint. They build the illusion that we understand what we are looking at, what we are experiencing, what we are living through.

My paintings hover on the edge of dissolution, questioning what is real and what is simply paint."

Only recent work (last two years) that has not been in a previous juried show at the NHAC may be submitted. Artist will be notified to pick up any unaccepted entries.

Pieces must be ready for display or hanging with picture wire. **Work with gallery clips or saw tooth clips will not be accepted.**

The NHAC is not responsible for damages, loss or theft to any piece during, or if left, after the show. Artwork not picked up after 30 days following show closing will be discarded.

The NHAC will take a 30% commission on any piece of exhibited art that is sold.

No piece of artwork shall be substituted or removed until the last day of the show.

This is not a juried entry show. Artwork is juried for awards only. However, the art center retains the right to reject artwork that is deemed inappropriate.
